### 4. DELEGATIONS:

Jen Baker provided the 2019 year end WildSafe report noting the actions undertaken during the year. Jen advised that there was a reduction in black bear reports over the year and that deer issues were on par with 2018. The complete WildSafe report will be available on the organizations website shortly.

Jane Thurgood Sagal provided highlights of library initiatives undertaken during the year and explained their proposed 2020 budget and grant request.

## 5. COMMITTEE REPORTS:

Mayor Reinhardt provided the RDEK Board meeting report noting that the District of Invermere has requested ongoing operational funding for the Columbia Valley Centre. The funding request will be discussed further during budget deliberations.

## 6. NEW BUSINESS:

Council discussed the request for an extension to the deadline for meeting the remedial action requirement for Lot 1 District Lot 486 Kootenay District Plan NEP71307. During the discussion, it was noted that the property has been subject to clean up requests since 2010, and that the new property owners were aware of the condition of the property at the time of purchase in 2019.

Resolved, that upon consideration, the Village will not provide an extension to the deadline to satisfy the remedial action requirement for the property described as Lot 1 District Lot 486 Kootenay District Plan NEP71307, owned by 0731543 BC Ltd. (Moved by Mayor Reinhardt)

Carried.

Council authorized staff to proceed with the demolition of the Old Rink.

## 7. SUNDRY MATTERS & QUESTIONS:

Mayor Reinhardt noted the email she received from Carleen Campbell regarding truck parking issues. Council discussed the formation of a joint Chamber and Village committee to see if solutions could be reached to the issues identified by Ms. Campbell.

Councillor Gray also raised the possibility of providing labor training in conjunction with Village construction projects, noting that grant assistance may be available. Staff will review these partnership opportunities so that they remain on our radar for future projects.

Mayor Reinhardt requested that staff send a letter to BC Hydro thanking them for getting power to Rotary Park prior to Christmas.
