# BYLAW NO. 461, 2020.

Being a bylaw to provide for a permissive exemption from taxation of lands.

**WHEREAS** the municipality has the authority under Part 7, Division 7, Section 224 of the *Community Charter* to exempt from taxation additional land held by a religious organization.

**NOW THEREFORE** the Council of the Village of Radium Hot Springs in open meeting, assembled **ENACTS** as follows:

1) The following land and improvements shall be exempt from municipal taxes for the 2021 taxation year:

Folio #03760.010 PID# 027-729-761 Lot 1, Plan NEP87941, District Lot 2580, Kootenay Land District, The Roman Catholic Bishop of Nelson.

Folio #03760.030 PID# 027-729-788 Lot 3, Plan NEP87941, District Lot 2580, Kootenay Land District, The Roman Catholic Bishop of Nelson.

Folio #03760.040 PID# 027-729-796 Lot 4, Plan NEP87941, District Lot 2580, Kootenay Land District, The Roman Catholic Bishop of Nelson.

Folio #03760.050 PID# 027-729-800 Lot 5, Plan NEP87941, District Lot 2580, Kootenay Land District, The Roman Catholic Bishop of Nelson.

- 2) This permissive exemption shall include the entire lot for each property noted above. Currently the properties, held in the name of Roman Catholic Bishop of Nelson, are used for a church, church parking and 'Stations of the Cross'.
- 3) This bylaw shall be cited as "Tax Exemption (Church Properties) Bylaw No. 461, 2020".

#### PURPOSE OF BYLAW:

To make miscellaneous amendments to the Upper Columbia Valley Zoning Bylaw.

#### LEGAL DESCRIPTION & GENERAL LOCATION:

The bylaw covers RDEK Electoral Areas F & G which covers the Columbia Valley from Canal Flats to Spillimacheen, including the communities of Panorama, Fairmont Hot Springs, Windermere, Edgewater and Brisco.

## OTHER INFORMATION:

Proposed Amendments are the following:

- Interpretation Section shift information on how height is calculated to an interpretation section of the Bylaw.
- Definitions Section changes to reflect consistency of definition with the Unsightly Premises Bylaw for derelict vehicles.
- General Regulations Section:
  - New section clarifying the permissible heights for buildings and structures with single pitch roofs (e.g. shed roofs) or flat roofs and how the height will be calculated.
  - Site specific zoning for C-2 parcel to accommodate existing mini storage facility.
- Parcel Area Requirements amendment to reduce the size requirement for common lot access parcels within
  a fee simple subdivision.
- Parking Requirements amendments to include requirements for the size and number of disabled off-street parking spaces and updates for cannabis related uses.
- A-2, Rural Residential Country Zone to remove a site specific permitted use in the Edgewater area.
- C-2, Service Commercial Zone to remove mini storage facility and accessory boat and RV storage as a permitted use and delete a site specific permitted use in the Windermere area.

#### Radium Hot Springs Centre Covid-19 Rental Policy - October 2020.

The following policies are meant to guide the rental of the Radium Hot Springs Centre (the "Centre") and shall be supplementary to Provincial Health orders, WorkSafe BC requirements, and the Radium Hot Springs Centre Covid-19 Safety Plan.

- 1. The Centre rental agreement holder (the "organizer") shall be responsible for developing a Covid-19 safety plan which is specific to their proposed rental activity. These activity specific Covid-19 safety plans (the "event safety plan") will be submitted to the Village of Radium Hot Springs (the "Village"), and will become part of the rental agreement for the Centre. These event safety plans may follow the template provided by WorkSafe BC. The Village may request revisions to the event safety plan. The Village acknowledges that any review of Covid-19 event safety plans is performed on a 'best efforts' basis only. It shall be the organizer's responsibility to educate the participants at their event of the requirements of the Radium Hot Springs Centre Covid-19 Safety Plan, the event safety plan, and the current Provincial Health Orders regarding Gatherings and Events, or any similar such Order, and to enforce these requirements. Village Council and staff will not be held responsible for the efficacy of these event safety plans, as the assessment of Covid-19 event safety plans is outside of the level of expertise of staff.
- 2. The September 18<sup>th</sup>, 2020 Provincial Health Order *Gatherings and Events* requires the Village to satisfy itself that the organizer is aware of the requirements of the Order. The Village will accept an attestation by the organizer, so as to meet this requirement. Village Council and staff will not be held responsible for any failure, on the part of the organizer, to follow the Provincial Health Order requirements.
- 3. The September 18th, 2020 Provincial Health Order *Gatherings and Events* requires the Village to satisfy itself that the organizer has the capacity to fulfill the requirements of the Order. The Village will accept an attestation by the organizer, so as to meet this requirement. Village Council and staff will not be held responsible for any lack of capacity, on the part of the organizer, to follow the Provincial Health Order requirements.
- 4. The following rules and requirements will apply to rentals of the Radium Hot Springs Centre:
  - The use of alcohol is not permitted.
  - Events shall terminate no later than 11:00 p.m.
  - The preparation of food on-site is not permitted. Catered or food prepared off-site may be brought to the Centre for event participants, provided that the appropriate Interior Health permits are secured, if required.

- Events involving loud music, live bands, dancing, and/or events of a 'party' nature, are not permitted.
- These rules and requirements may be waived by Village Council, by resolution, at their discretion.

## **Detachment Personnel Status**

The Columbia Valley Detachment is currently fully staffed. Our Detachment consists of the following:

- 1 Sergeant (Detachment Commander)
- 2 Corporals (Supervisors)
- 8 Constables (Provincially funded)
- 3 Administrative Staff
- 1 Reserve Constable
- 1 Victim Services Worker

## **Online Crime Reporting**

Columbia Valley Detachment is preparing to move forward with an Online Crime Reporting option which will allow individuals to report certain types of property crime online. Citizens will be able to report the following crimes online:
- Damage/mischief to property under \$5,000

- Theft of bicycles under \$5,000
- Theft under \$5,000
- Theft from vehicle under \$5,000
- Lost property

Incidents must also satisfy the following conditions to be reported online:

- No witnesses or suspects
- Item(s) lost or stolen must cost less than \$5,000
- Vandalized property will cost less than \$5,000 to repair
- There are no items involving personal identity; firearms, licence plates or decals.

Page 1 of 3 Canada. After an online crime report is created, the complainant will receive a file number and the file will be sent to the Detachment. The online crime reporting project aims to alleviate pressure on the Operational Communications Centre, Detachment staff and frontline members. It is also one way we are working to innovate and modernize our Detachment.

## Calls for Service

The total number of calls for service throughout the Columbia Valley Detachment area for the second quarter (July - September) was 1307. During the same quarter in 2019 our calls for service were 1076 and in 2018 we received 1102 calls.

The specific calls for service for Radium Hot Springs were as follows:

Calls within Radium Hot Springs accounted for approximately 7 % of our calls for service.

#### **Detachment Priorities**

The Detachment Priorities for 2020/2021 are:

- Road Safety Our objective is to enhance road safety. We will be making efforts to increase our presence on our roadways and in our communities. Our volunteer Speed Watch group is active in the Fairmont Hot Springs area. We will continue to work closely with East Kootenay Traffic Services and request additional traffic support for special events. Our officers had 82 documented pro-active officer/violator contacts which was up from 62 contacts during the last quarter.
- Crime Reduction Our objective is to reduce property crime. We will be making efforts to increase our presence on our roadways and in our communities. Our officers will be encouraged to conduct foot patrols, boat patrols and bike patrols. We will continue to strategically target our prolific offenders. Citizens on Patrol were active in Radium Hot Springs this summer. There were 18 thefts from vehicles and 11 thefts under \$5,000 during this quarter. During the same period in 2019 we had 14 thefts from vehicles and 18 thefts under \$5,000.
- Youth Our objective is to prevent and reduce the incidence of crime involving youth. This fall our Detachment will be introducing the WITS (Walk Away, Ignore, Talk it out, Seek help) program to three additional elementary schools. Our officers conduct regular visits to our schools to build on relationships with the staff and students.
- Substance Abuse Our objective is to reduce substance abuse in our communities. We are currently working with community members and other partners on more than one drug trafficking investigation. Our officers continue to make efforts to disrupt drug trafficking by any lawful means available to them. Citizens are encouraged to share any information they have with respect to drug trafficking.

## Seasonal Policing Enhancement

This summer our detachment received \$8,000 from Southeast District for seasonal policing initiatives. This was consistent with the contribution from last year. As most special events were cancelled this summer, we were able to show more of a presence on the lakes this summer. Our goal was to put thirty hours of patrol time on our police boat. With the assistance of officers from neighbouring detachments, Reserve Constables and the Conservation Officers Service we were able to log approximately 28 hours on our boat. The enhanced presence was well received by the public.
