#### **1. ORDER:**

Mayor Reinhart brought the meeting to order at 7:31 p.m.

#### **2. LAND ACKNOWLEDGEMENT:**

Mayor Reinhardt acknowledged First Nation's heritage for the lands upon which this meeting is being held. Clara emphasized the need to focus on reconciliation, at this time, especially in light of the residential school legacy.
