Mayor and Council Quarterly Report - Radium Hot Springs Third Quarter - 2021/2022

#### <u>Introduction</u>

This report is a summary of the activities of the Columbia Valley Detachment for the period of October 1, 2021 to December 31, 2021. During the third quarter our Detachment handled 985 files which was up from 739 files during the same period last year.

#### **Detachment Personnel Status**

Our Detachment, when at full strength, consists of the following:

- 1 Sergeant (Detachment Commander)
- 2 Corporals (Supervisors)
- 8 Constables (Provincially funded)
- 3 Administrative Staff
- 1 Victim Services Worker

Corporal LP Gendron-Fafard has been promoted to the North District and his last shift in Columbia Valley will be in February. The Corporal position is expected to go to promotion so it is unlikely we'll have it filled before the summer.

I'm excited to report we will have two familiar officers returning to our Detachment this spring. Constable Danny Butler, who previously worked at the Columbia Valley Detachment, will be returning in the coming months. Retired Corporal Brent Ayers has also rejoined our ranks as a Reservist. Brent will be updating his training in January and will be on our schedule in February. A third Constable from the Interior has expressed an interest in transferring to our Detachment and is expected to be released for her current detachment in March.

#### **Detachment Priorities 2021/22**

For 2021/22 our Detachment Priorities will be Road Safety, Substance Abuse, Youth, and Employee Wellness.

Road Safety - Columbia Valley General Duty members will again be encouraged to conduct pro-active traffic enforcement in the Columbia Valley. These officer-violator contacts will address road safety, drugs and property crime offences. Additionally, I will work collaboratively with Golden and Cranbrook Highway Patrol Unit Commanders in an effort to have more traffic resources in our area during periods when Trans-Canada traffic is diverted into the Columbia Valley.

Update - Columbia Valley RCMP and Cranbrook Highway Patrol increased their presence on Highway 93 and Highway 95 during the full closure of the Trans-Canada Highway. The Highway Patrol unit spent approximately 1000 hours patrolling the Columbia Valley highways during the full closure.

Substance Abuse - A current list of all available support services in the Columbia Valley will be compiled, updated and made available to our members. Members will liaise with local support services to determine how we can work together to address addictions and mental health. Proactive contacts will be made with those suffering from addictions to try to connect them with supports and services.

Update - This past quarter, two additional proactive contacts were made with individuals suffering from addictions. In one case, an individual from Calgary found himself in Invermere without any transportation, money or shelter. Officers made efforts to connect him with local resources but after all other support agencies failed to assist him, officers took it upon themselves to provide him with a meal and personally arrange transportation for the man back to his residence in Alberta to ensure he wasn't left out in the cold.

Youth - Columbia Valley Detachment will continue to build on relationships with school administrators, staff and youth. Members will be encouraged to seek out opportunities to engage with youth in formal settings such as school programs and informal settings such as youth centers, organized sports and skate/bike parks. Flexibility will also be provided to members who wish to coach or mentor youth in sports/activities.

Update - Columbia Valley police officers continue to make efforts to be visible in our local schools. Over the last quarter, members delivered eleven WITS presentations to primary school students. Additional presentations are planned in Edgewater and Canal Flats. In December an officer made time to attend a Christmas lunch at a local school and helped by serving the students. Two officers are currently volunteering their time to coach minor hockey.

**Employee Wellness** - Employee Wellness - This past year has been a difficult time for everyone, including our officers and detachment staff. Employee wellness is a priority for me. I will be seeking out opportunities to provide wellness training to our Detachment members and staff. Areas of focus will be mental and physical health for our members and their families. Once restrictions are lifted I will also be prioritizing operational skills training.

Update - After several years of planning, Columbia Valley Detachment introduced a pilot project to provide our members and their families with an opportunity to meet with, and receive support from our District Chaplain. Dr. Tim Schroeder was invited to our detachment in December and over the course of three days he rode along with our officers to receive feedback on how the RCMP can better support our members and their families. His visit culminated with a dinner for members, staff and their families with Dr. Schroeder as the guest speaker. The visit was very well received and the hope is to expand this project to other detachments.

#### **Calls for Service**

The total number of calls for service throughout the Columbia Valley Detachment area for the third quarter (October-December) was 985. During the same quarter in 2020 our calls for service were 739 and in 2019 we received 675 calls.

Specific calls for service for Radium Hot Springs were as follows:

Calls within Radium Hot Springs accounted for approximately 7% of our calls for service.

#### **Kicking Horse Canyon Diversion**

The full closure of the Trans-Canada Highway was in place from September 21st to December 1st. The highway diversion resulted in an increase in traffic related calls for our Detachment.

Traffic Complaints (September 21 - November 30) - 2021 = 105, 2020 = 58
Collisions (September 21 - November 30) - 2021 = 69, 2020 = 40
Of the 69 collisions that occurred during the highway closure, 35 occurred on Highway 93, 12 occurred on Highway 95, 7 occurred on Highway 93/95 and 15 occurred in other locations.

During this period the RCMP's East Kootenay Highway Patrol unit was instrumental in providing enhanced enforcement on our local highways. Planning has begun for the next full closure which is scheduled from April 19-May 20, 2022.

#### 2022/23 Detachment Priorities

Over the next two months our Detachment will be reassessing our Detachment Priorities. This past year our priorities were Road Safety, Substance Abuse, Youth and Employee Wellness. My question to our elected officials is, do these priorities continue to address our local issues and concerns? Your feedback is welcome.



#### Administrative memo to Council

#### **Columbia Valley Transit Service Expansion**

#### February 3, 2022

The RDEK is proposing an expansion to the Columbia Valley Transit service which would provide increased service to Edgewater, Radium, Invermere, Fairmont Hot Springs and Canal Flats.

Radium is part of the North service loop which runs from Edgewater to Radium and Invermere. The proposed increase in service would provide for 2 additional trips per day Monday to Friday on the North loop and add Saturday and Sunday service.

Currently the cost of providing this service is \$0.033 per \$1,000 assessed value. The proposed transit service expansion would cost approximately \$0.125 per \$1000 assessed value.

This proposed service expansion will require an assent vote from the electors which would take place at the same time as the municipal elections this fall.

Option 1 Consent Approach 1 Assent vote undertaken for Electoral Areas F & G conducted by the RDEK. Municipal councils provide consent on behalf of their electors as participating area approval. No voting required in Radium.

Option 2 Consent Approach 2 Collective approval over the entire service area. The total number of votes over the entire service area must be a majority to achieve assent of the electors.

Option 3 Consent Approach 3 All five areas vote individually and votes are counted by area. If one area has less than a majority, then that area would not receive increased service.

The RDEK Board of Directors resolved at their Dec 3, 2021 meeting that letters be sent to the municipalities requesting support for council consent on behalf of electors as participating area approval for the proposed Columbia Valley Transit Service Expansion. (Option 1).

The RDEK is requesting consideration from municipal councils to support Consent Approach 1. Proposed resolution:

That Council supports Consent Approach 1 providing consent on behalf of the electors as participating area approval for the Columbia Valley Transit service expansion proposal.

Re: Columbia Valley Transit Service Expansion

At the December 3, 2021 RDEK Board of Directors meeting, it was resolved that letters be sent to the District of Invermere, Village of Radium Hot Springs and Village of Canal Flats requesting support for council consent on behalf of electors as participating area approval for the proposed Columbia Valley Transit Service Expansion.

In the fall of 2020, the Board requested to be included in BC Transit's Transit Improvement Process for an expansion of the Columbia Valley Transit System. The service expansion would include:

- Expansion of the Edgewater and Radium commuter route and the local Invermere Service; and
- Implementation of a weekend service to current Routes 1 & 2.

The system currently has two routes that share a terminus at Invermere Hospital. Route 1 South Connector - makes two round trips per day from Canal Flats to Invermere Hospital, stopping at Fairmont Hot Springs and Windermere in between. Route 2 North Connector - is designed as a loop route between Invermere Hospital and Edgewater, with a stop in Radium Hot Springs in between. The bus schedule enables residents, students, and visitors of smaller communities to make day trips to Invermere. The service operates five days a week, with no service on weekends or public holidays.

The proposed Edgewater and Radium Commuter Service and Invermere Local Service improvements would introduce two additional round trips on Route 2 (Invermere / Radium / Edgewater) and introduce local service in Invermere that operates 13 round trips per day. The benefits of this improvement would provide more opportunities for commuters from Radium and Edgewater to get to and from work in Invermere. The Invermere Local service improvement would provide more opportunities to travel to key destinations within Invermere.

The proposed implementation of weekend service would replicate current weekday Route 1 and Route 2 service on Saturday and Sunday to provide opportunities to take transit to work and recreational activities on the weekend.

These service improvements are consistent with evolving local priorities and emergent transit demands.

Implementation of the proposed service expansion will require an increase in taxation of \$400,000 per year. Given the significant increase to taxation elector assent will be required.

The Columbia Valley Transit Service Establishment Bylaw No. 2003 allows for a maximum taxation rate of \$0.06/\$1,000. The tax rate for 2021 was \$0.033, so there is room to increase taxation based on the bylaw, but not to the required amount. It is expected that the increased service would require a tax rate of \$0.125/\$1,000 which would require approval of the electors as it is above the allowable threshold for increasing with Board approval. With a buffer for future cost increases, the requisition limit established in the bylaw would need to be around \$0.15/\$1,000. The following table outlines the impact on taxes for select property values.

When more than one jurisdiction participates in the assent voting the regional district board must, by bylaw, establish the question that will be used by all the areas participating and set the date(s) for advance voting, as well as establish any additional voting opportunities. The board has the authority to determine if assent voting will be conducted separately by each participant in the service or held for the entire proposed service area. There are a few approaches that can be taken to obtaining elector assent:

#### **Consent Approach 1:**

The electoral areas must achieve a majority of votes, and the municipalities consent on behalf of their electors as participating area approval for a regional district service.

- a) Assent vote undertaken for Electoral Areas F & G conducted by the RDEK. The votes could be counted separately or altogether.
- b) Municipal councils provide consent on behalf of their electors as participating area approval.



# Consent Approach 2: Collective approval over the entire service

If the board decides to seek approval over the entire service area (municipalities and electoral areas combined), then the total number of votes received must be a majority of votes cast to achieve assent of the electors. Each area would conduct an assent vote in collaboration with the RDEK and count the votes together.



# Consent Approach 3: All five areas obtain votes separately

Each area must achieve a majority of votes in favour to achieve assent of the electors. If one area has less than majority, assent of the electors has not been obtained and the funding available for the service would be diminished by the amount equivalent to that which would be taxed in that area. Each area would be conducting their own assent vote.











The Board has determined the transit service expansion as a priority with the assent vote to coincide with the 2022 general election. Conducting an assent vote in conjunction with the general election will be a multifaceted project with increased complexities and collaboration.

We are requesting Council's consideration to support Consent Approach 1, where municipal councils provide consent on behalf of their electors as participating area approval and are seeking a resolution that the Columbia Valley Transit service expansion be supported at this preliminary stage, or alternatively, a recommendation from Council of a different consent approach.

To ensure that there is adequate time to implement a regional assent vote, please provide a council resolution no later than February 28, 2022.

Dear Members of Radium Hot Springs Council, I am writing to follow up on previous correspondence which I sent to you over the summer. I am the Chair of the AccessBC Campaign for free prescription contraception, a grassroots, province-wide campaign that advocates for universal no-cost prescription contraception in British Columbia. Our campaign was founded in 2017, and comprises a team of amazing volunteers from across the province.

We have been reaching out to municipalities across the province and asking them to endorse universal no-cost prescription contraception as part of our efforts to galvanize public pressure supporting this policy.

To date, 29 municipalities and districts have passed motions supporting universal access to no-cost prescription contraception and have written to the provincial government urging them to adopt this policy as soon as possible.

Universal no-cost prescription contraception improves health outcomes for mothers and infants, increases equality, makes life more affordable for people, and will save the government millions. You can learn more about barriers to prescription contraception and the benefits of universal no-cost prescription contraception in our Briefing Paper [1], as well as and more about the AccessBC Campaign.

We are working to ramp up pressure leading up to the forthcoming 2022 provincial budget, and municipal endorsements have a huge impact. As such, our campaign is reaching out to municipal councils to ask them to endorse universal no-cost prescription contraception before the end of February 2022. If your municipality passed a motion since we last got in touch this summer, please let us know so we can sing your praises! If you haven't yet had a chance to adopt a motion, now is the perfect opportunity, and doing so can take less than 10 minutes of your council's time. I am writing to you today in order to ask if your municipality would be willing to step up and call on the provincial government to make all prescription contraception universally available at no cost?

To help out as much as possible, we have drafted a sample motion which you are welcome to amend as needed:

Universal No-Cost Coverage of Prescription Contraception WHEREAS cost is a significant barrier to people accessing contraception, particularly to people with low incomes, youth, and people from marginalized communities; WHEREAS providing no-cost prescription contraception has been shown to improve health outcomes for parents and infants by reducing the risks associated with unintended pregnancy, and is likely to reduce direct medical costs on the provincial health system; WHEREAS contraceptive methods targeted at men (such as condoms or vasectomies) are available at low cost or are covered by BC's Medical Services Plan, whereas contraceptive methods for people with uteruses (such as birth control pills, intra-uterine devices, or hormone injections) have high up-front costs, making access to contraception unequal and gendered; THEREFORE BE IT RESOLVED THAT Council directs the Mayor to write to the Provincial Government to urge them make all prescription contraception in BC available at no cost under the Medical Services Plan.
